# JOB OPENING ANNOUNCEMENT SANITATION WORKER FULL-TIME POSITION

Great employment opportunity in Northwest Nebraska. Have you been looking for a way to contribute to the efforts of serving residents and entities in our service area of Northwest Nebraska. SWANN, an *Essential Service Organization*, has an opportunity for Sanitation Worker with the Agency facilities located in Chadron, Nebraska, at the Transfer Station. *Position open until filled*.

### **Job Description:**

• The primary purpose of this position is to safely perform routine specialized work in the operation of the baler machine, loaders, roll-off truck and other associated landfill and disposal equipment, along with all duties assigned. The Sanitation Worker may also serve as back-up refuse collection truck driver.

## Essential Functions (sample of duties/not inclusive):

- Assist customers with proper separation of materials, and proper disposal of appliances, tires, waste oil, yard waste, and other disposal and/or recyclable material as required
- Works as a member of a team and rotates duties as directed or according to the team schedule.
- Assist in completing inspections of all loads received at the transfer station.
- Assist in conducting screening of loads for any special wastes
- Assist the public in unloading waste loads.

- Assist any contract haulers or agency haulers in unloading.
- Operate the baler and assist with any maintenance or repairs of the baler as required.
- Remove bales and stack in the appropriate designated areas.
- Load bales for transportation to the landfill.
- Transport waste to the landfill as required
- Sort and process recyclables as required.
- Any other duties assigned.

#### **Qualifications:**

- ✓ Graduation from high school education or GED equivalent and any combination of education/experience.
- ✓ Experience in solid waste industry helpful, but can be substituted for experience working with equipment, field operations and technical compliance issues.
- ✓ Valid Nebraska Driver's License. / Valid Nebraska Class B Commercial Driver's License.
- ✓ Ability to obtain a Nebraska Class A Commercial Driver's License within 90 days of hire date
- ✓ Pass pre-employment drug/alcohol testing and ongoing random drug/alcohol testing per Dept of Transportation requirements. Must be able to pass NDEQ Hazardous Waste Screening Class within six (6) mos.
- ✓ Skill in operation of the provided tools and equipment (i.e. two-wheeled cart, common hand & power tools).
- ✓ Ability to work in inclement weather environments.
- ✓ Ability to accurately screen in-coming waste; ability to establish effective working relationships with other employees, supervisor and the general public.

#### **Job Pay/Benefits:**

- Non-exempt full-time position.
- Full-Time, 40 hours weekly (typically)
- Starting pay range: \$17.78 to \$19.15 (dependent upon experience/education)
- Holidays- seven primary holidays, plus birthday for total of 8 days
