JOB OPENING ANNOUNCEMENT COMMUNITY SITE OPERATOR PART-TIME POSITION

Great part-time employment opportunity in Northwest Nebraska. Have you been looking for a way to contribute to the efforts of serving residents and entities in our service area of Northwest Nebraska. SWANN, an *Essential Service Organization*, has an opportunity for Community Site Operator with the Agency facilities located in Hay Springs, Nebraska. *Position open until filled.*

Job Description:

- Position is responsible for performing a variety of unskilled and semi-skilled work, and provides proper access control, separation and disposal of solid waste at designated Agency community site.

Essential Functions:

- Assist customers with proper separation of materials, and proper disposal of appliances, tires, waste oil, yard waste, and other disposal and/or recyclable material as required
- The community site operator will have a thorough understanding of operating procedures established by the Agency concerning proper separation and disposal of acceptable materials at each site.
- Understands, requirements and collects/submits collected fees (checks preferred) and scale tickets, as established by the Agency ensuring that chargeable materials are paid for
- Responsible for litter control and clean-up as well as keeping signage and designated painted areas in good condition.
- Will keep the Operations Director informed as to the status of collection containers. Informs Operations Director of burn pit status and conducts burns as prescribed by the Operations Director.
- Opens and closes community sites at the proper specified time.
- The operator will screen incoming loads/refuse prohibited items as required and maintain required records.
- Performs all duties in conformance to appropriate safety and security standards and advises/informs the Operations Director as to any safety matter requiring attention.
- Any other duties assigned.

Qualifications:

- ✓ Graduation from high school education or GED equivalent and any combination of education and experience.
- ✓ Experience in solid waste industry helpful, but can be substituted for experience working with equipment, field operations and technical compliance issues.
- ✓ Valid Nebraska driver's license.
- ✓ Skill in operation of the provided tools and equipment (i.e. two-wheeled cart, common hand & power tools).
- ✓ Ability to work in inclement weather environments.
- ✓ Ability to accurately screen in-coming waste; ability to establish effective working relationships with other employees, supervisor and the general public.

Job Pay/Benefits:

- Non-exempt part-time position.
- Part-Time 15-30 hours weekly (typically)
- Starting pay rate: Minimum Wage Rate or Dependent Upon Experience. Highly Competitive and Negotiable.
